Strategic Plan Goal Change – Denae Pruden:

Denae spoke with the administrative team about changing goal #2 on the five year strategic plan. They wanted to make sure that what needed to be measured could be measured. The goal currently reads, "At least 90% of TECS students enrolled for at least one year will make one year's worth of growth in one year's time on in-house assessment measures."

The goal was changed to: "TECS students will meet or exceed the annual average growth compared to past cohorts as measured by the current trend-line on the in-house monthly testing report."

Engineering Report – Brad Larsen:

With the newly acquired property, Cache Valley Landmark is proposing increasing the parking lot and adding an additional drop-off pick-up lane. The existing parking lot would be restriped and the main crosswalk would be coned off during drop-off and pick-up. Traffic would come in off of 12<sup>th</sup> West.

This provides a lot of stacking room so traffic on the roadway is not blocked. They also propose a crosswalk to the townhomes. The triangle shaped piece of land will serve as a storm water pond or mimic the wetland and fence on Nibley Park Avenue. The fence will be 15 feet back so snow can be pushed to that area.

The parking lot was designed with striped islands to aid in snow removal. The number of parking stalls will increase from 100 to 185.

### Finance Report/Forecast Report – Jim Peterson:

Edison North is just under \$8,200 per month in the black. Edison South is about \$13,700 per month in the black.

Jim explained the budget forecast tool and what controls he set for the printed forecast. The board all received an electronic copy and he told them how to change controls or scenarios. The cash surplus does not update automatically.

#### Legislative Update – Jim Peterson:

Jim supplied a list of bills in the legislature this session that might be of interest to or impact the schools. He explained about the education base budget which will be amended at the end of the session. He highlighted a few other bills.

HB282 is trying to charge a fee for Aspire, but it does not seem to be moving yet.

SB70 requires charters and districts to have certain HR policies.

*HB233* makes changes to the salary supplement. This would include special education teachers in the list of qualified teachers and it may increase the amount of the supplement in certain cases.

## Achievement Report – Denae/Kyle/Jamin/Kari:

Kari presented the results for Aspire, which is a preparatory test for the ACT. There are three indicators, Exceeds, Ready and Close. The benchmarks are for the spring, but TECS administers the test in the fall.

Audra pointed out that the 8<sup>th</sup> grade is above the national average in every category. There were a lot less 9<sup>th</sup> graders who took the test so that may skew their scores.

Kari also presented some graphs showing comparisons with last year. The test has to be taken in one sitting. It is long and laborious for the students.

## Engineering Report – Brad Larsen:

Civil Solutions proposed two separate entrances to reduce conflict in that area. The crosswalk will remain for students to cross to the other pick-up area. You will be able to enter or exit from 12<sup>th</sup> West. The area to the right will serve as a pick-up area and may double as parking during events. The total number of parking stalls, including the event parking, will be 151.

They also propose drain water and snow storage for the triangle portion.

# Vendor and Contract Approvals – Shem/Melani:

The board asked Brad his recommendation. Both firms have been responsive and easy to work with. Cache Landmark has been a little more proactive and creative, but he feels either firm would do a good job.

Denae liked the Cache Landmark design a little better and especially the flow and the amount of added parking stalls.
