Adam asked the administration what stands out most to them. Melani said that there needs to be some changes in how things are tracked so the information is more useful.

Shem would like a tool that would useful for both parents and the governing board. He thinks it could be made more user friendly with more meaningful data that might guide interventions.

Health and Dental Renewals – Audra Parent: The committee recommended that the health insurance stay with same provider and plan. The expected increase was over 20%, but Ernie got them to increase by only 9.7%

Counseling Report – Jamin Bingham:

- CCR meetings were held for 8th and 9th graders and their parents. 100% of 8th grade parents attended the meetings at Edison North, 97% at Edison South. One of the local districts had a goal of having 40% of parents attend sometime during their high school. Edison South saw 100% of 9th grades parents attend.
- An expanded college week was held this year. A form was sent home with students containing topics to speak about with parents. Students turned in the signed forms and were entered in a drawing. The counseling department again supplied Aggie ice cream to students and staff. Ninth graders were given the opportunity to take the ACT at USU.
- Lessons are taught at both Edison South and Edison North.
- The 8th and 9th graders job shadow for half of a day, then complete an English assignment associated with it.
- Citizenship parties took place in the theaters and Fun Park. Pizza was supplied.

- In the upcoming year the state will do a review of the program. A survey will be conducted before that to create a needs assessment.
- Small groups are created for students who need a little more help.
- Some students are met with on an individual basis.

Shem mentioned there was a data project on college week and the counselors are trying to increase awareness with parents and students on college and career awareness.
